OFFICE-ORDER

Whereas the association namely, Shristi Special Academy, 13/1, 9th 'G' Main, Byraveshwarnagar, Moodalapalya, Bangalore - 560 072 (Karnataka) (hereinafter referred to as the association) is registered vide Regn. No.094420834R under Section 11 of the Foreign Contribution (Regulation) Act, 2010 (hereinafter referred to as the 'The Act').

Whereas the association is required under Rule 17(1) of Foreign Contribution (Regulation) Rules, 2011 to submit a report in Form FC-6, accompanied by an income and expenditure statement, receipt and payment account, and balance sheet for every financial year beginning on the 1st day of April within nine months of the closure of the financial year, to the Secretary to the Government of India, Ministry of Home Affairs, New Delhi.

Whereas the mandatory annual return for the financial years 2006-2007 has not been received at this end,

Whereas a Show Cause Notice was sent on its registered office in this regard, which was returned undelivered by the post office. Thus, while exercising the power vested under Section 14 of FCRA, 2010, the Govt. of India cancelled the FCRA Regn. No.094420834R of the Association on 19.07.2012.

Now the association vide its representation dated 22.08.2012 has enclosed the copy of returns alongwith proof of submission and requested for revocation of its cancelled registration. This Ministry has examined the request made by the association and an off-site inspection of the association was conducted on 27th February, 2013. During the course of inspection, the association produced the proof of submission of mandatory returns and no serious misutilization/ misappropriation of FC fund has been found. Therefore, keeping in view the utilization aspect, their representation is accepted and their FCRA Registration No.094420834R is hereby **RESTORED**. However, the association is required to submit the utilization of foreign contribution in the prescribed form well in time in future. The association is also advised to keep their knowledge regarding new provisions of FCRA, 2010 & FCRR, 2011 upto date.
